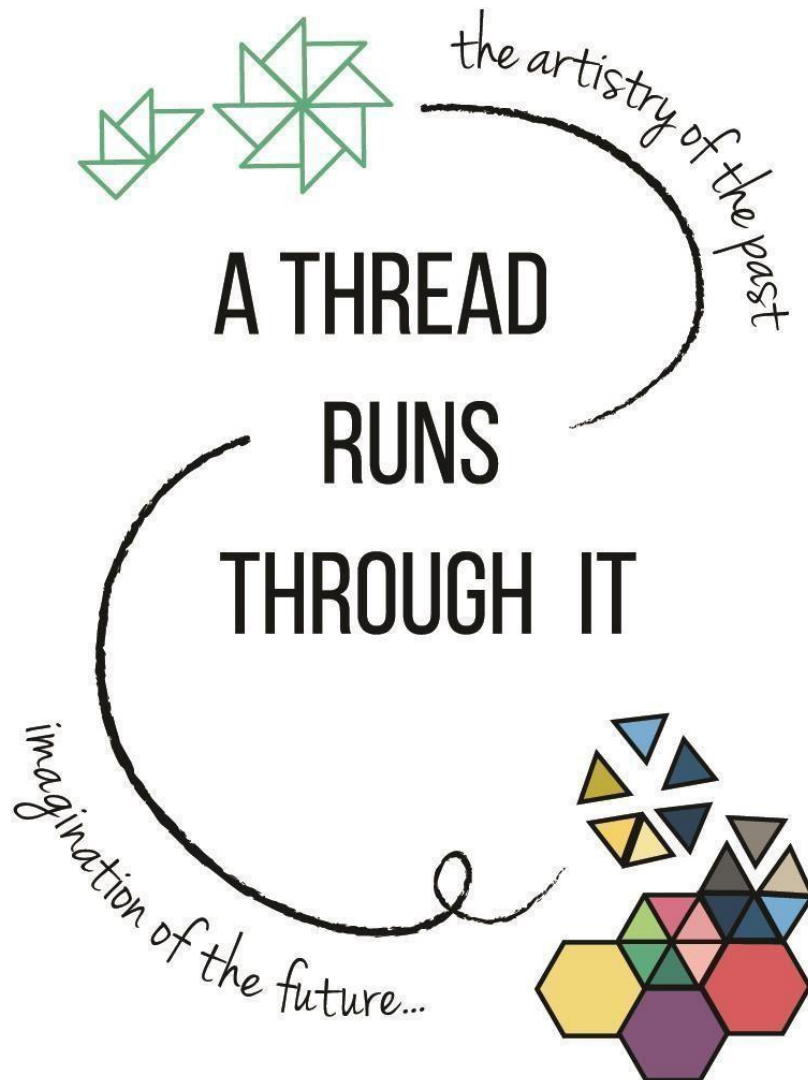


# Brandywine Valley Quilters Quilt Show

## Quilt Show **2018** Entry Rules and Form

*(Please note that for your convenience the forms in this packet are "fillable" if accessed on a computer)*

**Entry Rules**

1. Quilts must be completed, clean, odor-free and undamaged. **All items to be judged must contain a quilted element.** Tied quilts (other than crazy quilts) will not be judged. Quilts submitted previously for judging will not be accepted. The Quilt Show Chairs have the right to refuse an entry for cause.  
**The final judged categories will be determined based on the quilts entered for judging. Quilts will be placed in the most homogeneous groupings possible. Please contact Terry Lieberman (<mailto:quiltshowBVQ@comcast.net>) if you have questions about which category to enter your quilt. It is better to ask questions ahead of time than to enter the quilt in the wrong category.**
2. **A separate entry form is** required for each item. **Entry form(s) must be received by Tuesday, September 11, 2018.** Keep a copy of each form you submit for your records.
3. The appropriate **non-refundable fee** must accompany each application form. The fee for each display item is \$8.00. The fee for the first judged item is \$10.00. Additional judged item fees are \$8.00. Youth entries and BVQ challenge quilts (display only) are free.
4. **Two 4 x 6 Photographs (approximately)** of the entry must be submitted with this form. A digital / computer printout is acceptable. Identification on the back of photos must include: (1) name of maker, (2) title of quilt, (3) dimensions of quilt (width by length, in inches), and (4) special hanging requirements (for example, a reversible quilt). **(If submitting your photographs electronically there is an additional \$1.00 fee to cover printing)**
5. **Hanging Your Quilt:** To guarantee your quilt will be hung, it must have a sleeve firmly basted to the top back of your quilt. A 4" sleeve is required for quilts over 34" wide. A 2" sleeve is acceptable for quilts 34" or less in width.
6. **Label / identification** must be placed on the back of the quilt. On judged pieces, all identification (front and/or back) must be **temporarily covered**. Wearable art labels should be inside the garment(s).

7. **Judging of entries** will be prior to hanging. Written judges' evaluations will be given to each judged entrant. Ribbons for first, second, third, and honorable mention may be awarded by the judges in each category. Ribbons are awarded per quilt regardless of the number of people involved in its completion. Judges reserve the right not to award all ribbons. Judges' Choice, Harry's Choice, Best Use of Color, Viewers' Choice, Best Quilting, Best Interpretation of Quilt Show Theme and Best in Show are also awarded. Each Youth participant will receive a participation ribbon.
  8. **Drop Off:** Entrants are responsible to personally deliver and retrieve quilts. **Quilts must be delivered fully completed between 3:00 p.m. and 6:45 p.m., Wednesday, October 17th, to the Brookhaven Municipal Building.** A receipt will be given when the entry is dropped off. Receipt must be presented at pick-up time.
  9. **Pick Up: Quilts must be picked up between 5:00 p.m. and 5:30 p.m. Sunday, October 21st.** If the quilt is not claimed on Sunday, it will be the responsibility of the entrant to make arrangements for the return of the quilt. **NO QUILTS WILL BE RETURNED WITHOUT A RECEIPT.**

10. **Security** will be provided in the exhibit area. All quilts will be handled with the utmost care. BVQ cannot be responsible for loss or acts of nature beyond our control. BVQ **will not** be providing insurance and recommend you contact your homeowner's insurance carrier to understand what coverage is provided and how to obtain specific coverage for your quilt.
